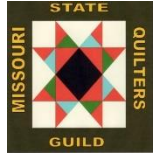

Thank you to all members who cast their vote. Here are the results:

Board Elections

One hundred percent voted to accept the slate of officers as presented. The elected members have agreed to accept the following positions on the Board:

Youth Membership Level

Seventy-one percent voted to create a youth membership level. NOTE: At the June 13th Board meeting it was decided to table any further action on this until the COVID 19 pandemic is under control.

State Fair Demonstrations

Twelve members volunteered to help with demonstrations at the State Fair. NOTE: At the June 13th Board meeting it was decided that, even though the State Fair is going to take place, we would not hold demonstrations this year due to the COVID 19 pandemic.

Flipping the Spring and Fall Retreats

Eighty-one percent voted in favor of moving the larger Fall Retreat to the Spring and holding it in Columbia and holding the smaller traveling retreat in the Fall. NOTE: At the June 13th Board meeting it was decided to postpone this action until the COVID 19 pandemic is under control.

MSQG Minutes

June 13, 2020

The quarterly meeting of the Missouri State Quilters Guild was called to order on June 13, 2020, at 10 a.m. at the Vichy Fire Station, Vichy, Missouri, by President Juanita Miner. Present were Juanita Miner, President; Janice Williams, Secretary; Cheri Quick, Ways and Means; Jeanette Gregory, Publicity; Brenda Hancock, Member; Gayla Barber, Fall Retreat and Grants; Barb Reininger, Treasurer; Martha L. Cox, Guest; Madeline Gieselman, Newsletter; Serena Crisp, Vice President; Ruth Rakop, Member; Bryan Nehl, eCommerce; Denise Nehl, membership elect; and Janet Viehland, Membership.

The January minutes were read and approved as read. The May Zoom meeting minutes were read and approved as read.

There was a discussion about the State Fair. There will be a State Fair but no one knows yet what will be happening. Madeline Gieselman questioned whether or not we had gotten the \$150 back that we paid to the State Fair and we have not.

Treasurer's Report—We currently have \$1686.55 in checking, \$17,735.12 in savings, \$211.51 in our square account totaling \$19,633.18. The treasurer's report was filed for audit.

The spring retreat was an in and out. If we have a fall retreat, the checks will be held until October 1 and then they can be mailed back if the retreat is cancelled.

Election/Voting—Serena Crisp mailed 15 ballots. 110 members voted.

Youth membership—80 voted yes, 2 voted no, 2 were returned with notes, one suggesting it should be promoted at a local level, one agreed if accompanied by an adult.

State Fair—91 voted no.

Flipping Retreat—87 voted yes, 22 voted no. Retreat may be too close to Paducah and the AQS show at Branson. Never felt we need to do a two or three day spring retreat.

100 percent accepted the board as presented.

Janice Williams commented that we had more people voting when voting online. It was super easy. Serena questions why we don't have a write-in. Comments were read and discussed.

Serena also questioned whether or not the individual appointed by the President needed to be voted on by the membership. Janet Viehland stated membership elects board members. Officers are elected by the board.

Barb Reininger made a motion that we pay mileage to the Newsletter and Ways and Means members. Jeanette Gregory seconded the motion. Motion carried.

Juanita stated the early newsletter should be out by July 15 to get counts for retreat. July and February newsletters are mailed. Email November and May newsletters.

Fall Retreat—Juanita called Capitol Plaza Hotel to speak with Kathy and was able to speak with Kelly who stated there will be no financial responsibility if we do not have a fall retreat. They would like to have a written notification soon. Juanita asked for written confirmation. It was decided Juanita will send an email. The retreat chair reported they cannot get donations because of the current situation. Barb expressed concern that the hotel will hold us responsible. Barb has a contract for 2020 and 2021. Juanita stated she did not sign a contract for 2021.

Juanita asked Gayla Barber if she would be willing to organize the fall retreat for 2021 and she agreed to do so.

Janet Viehland made a motion to cancel the 2020 fall retreat provided we have no financial burden. Jeanette Gregory seconded the motion. Motion carried.

Janet Viehland discussed an amendment to the contract. It was decided the email from Juanita should be followed by a written letter. Gayla Barber also offered the services of the law firm where she works, if needed.

Membership—Janet Viehland reported we have 221 members. She has not received very many renewals recently. She did get a new membership from Sue's Quilting Company. Sue's will give members a 20 percent discount. She noted they have the MSQG logo on their website stating they are proud members.

Ways and Means—Cheri Quick reported on the items she has received as donations. She is not getting a lot of response. It was decided to hold those items until the next retreat.

Publicity—Jeanette Gregory discussed how to keep members engaged since we are not having a retreat. She invited Teri Welch to discuss having workshops on Zoom.

There was a lengthy discussion regarding keeping members engaged. It was decided to try a workshop/demonstration on Zoom and to do a mystery quilt in the newsletter.

Jeanette Gregory made a motion that Bryan Nehl create a You Tube account, Zoom and monitored email group. Janice Williams seconded the motion. Motion carried.

The meeting adjourned to go into closed session.

The closed session was called to order by President Juanita Miner at 12 p.m. Members present were Juanita Miner, Janice Williams, Janet Viehland, Serena Crisp, Jeanette Gregory, Barb Reininger, Cheri Quick, and Madeline Gieselman.

Serena Crisp reported the following members were elected to the board: Juanita Miner, Janice Williams, Madeline Gieselman, Denice Nehl, Tanya Hamm and Cheri Quick.

Juanita Miner stated Gayla Barber will be the Fall Retreat chairman and Grant Chairman. Cheri Hofeldt will be the web maven.

Juanita Miner is nominated as president; Janice Williams, secretary; Madeline Gieselman, newsletter; Denice Nehl, membership; Tanya Hamm, HAL; Cheri Quick, ways and means. Janet Viehland made a motion the slate of officers be accepted as nominated. Jeanette Gregory seconded the motion. Motion carried.

Spirit Award—Barb Reininger made a motion that the 2020 Spirit Award be awarded to the list of nominees. Jeanette Gregory seconded the motion. Motion carried.

A motion was made to award the 2020 Spirit Award at the next fall retreat. Janet Viehland seconded the motion. Motion carried.

The closed session was adjourned.

The MSQG board meeting reconvened at 12:30 p.m.

Nominating Committee Elections

In addition to the new board members we should have also elected two new members to the nominating committee – we did not. Since we are not sure which two of the four committee members is leaving office Barb moved and Jeanette seconded that we table until we get some additional information. Motion passed. Juanita will contact Alice (current committee chair) to get information. Alice and Toni are going off of the Nominating Committee.

Youth Membership

The majority of members who cast a ballot voted to begin a youth membership level. Due to the current pandemic it was decided to table the development of this level and concentrate on providing for our adult members.

Membership Booklet

Question – If we don't have the Fall 2020 Retreat should we reprint the membership booklet or just send a page(s) containing updated information? The pages would contain contact information for any new members that have joined since the last printing and contact information for the new board and committee members. The pages would be sent out with the next newsletter. Discussion.

Decision - If the Fall 2020 Retreat is cancelled, do not reprint the membership booklet. Send out an updated contact list of any new members since the last printing and contact information of new board and committee members. This information would be sent out along with our next newsletter.

2020 Fall Retreat

Juanita will contact Capitol Plaza again on Monday to get confirmation in writing that we could be released, without penalty, from our 2020 contract. If that is the case, we will cancel the 2020 Fall Retreat.

Sewing Machine Update

Jeanette reported that, after many emails and phone calls, Janome provided a sewing machine for the child whose quilt won the contest held during the 2019 Fall Retreat and it has been delivered. This sewing machine was promised by Steve Tipple but was never delivered. Jeanette followed up with a letter to the Better Business Bureau reporting Steve's fraud.

Presentation of Quilt

Juanita was presented with the quilt that was created during the 2019 Fall Retreat. The hand-pieced blocks in this quilt were made as one of the activities during the retreat.

Voting on Grants

Gayla reported that she has contacted Raven Simms requesting additional information regarding her grant application that was tabled during our last board meeting. Raven has yet to provide the requested information so it was tabled again.

Gayla presented a second application made by Merrie Ford. Discussion. Serena moved to award the grant request of \$400 to Ms. Ford with the provision that some presentation be made by Ms. Ford in the future. Seconded by Barb. Motion carried

Bicentennial Quilt

Juanita reported that the quilt is being displayed in several places around the state. The schedule will be in the newsletter. If anyone has scheduled the bicentennial quilt, please contact Mike Sweeney, Coordinator, Missouri Bicentennial, 816-510-4823 (mobile) to confirm or cancel

Dues

Since we will be providing some on-line activities, we will charge dues for the following year. The reminder that dues are due will be in the newsletter.

By installing a client on your device, you can interact with a zoom server that is hosting a video conference that someone else started.

With zoom you can start your own meeting that other people can join. Using a password or entry lobby restricts who can join the meeting.

The MSQG is looking into hosting some zoom sessions for members. To participate you'll need to create an account with zoom. <https://zoom.us/signup> You can use an existing Google or Facebook account to sign in with.

You will need to download the software for your device. You can use a laptop or PC with a webcam, a phone or tablet. <https://zoom.us/DOWNLOAD>

Overall, it is usually a pretty straight forward process to set up zoom. Once, that is done, you'll get the hang of it and be able to see, talk and chat with others. You'll probably also find that quite a few other organizations are also using zoom.

MISSOURI STATE QUILTER'S GUILD

MYSTERY QUILT - A 5 PART MYSTERY PART 1

FABRIC REQUIREMENTS:

There are 8 fabrics in this quilt from very light to very dark. Choose a large main print (or border print) for the border, a medium print, and for the remaining 6 fabrics, choose small prints or tone-on-tones/blenders. Fabrics like white on white or batiks. These are fabrics that look almost solid. These should include a very light and very dark fabric and 4 coordinating and contrasting fabrics ranging from medium light to medium dark.

The quilt is 60" x 78". If you want to make it larger, plan on adding $\frac{1}{4}$ to h yard to each of the measurements.

Fabric 1: Light 1-7/8 yards

Fabric 2: Contrast #1 - 7/8 yard

Fabric 3: Contrast #2 - 3/4 yard

Fabric 4: Contrast #3 - 3/4 yard

Fabric 5: Contrast #4- 1 yard

Fabric 6: Dark — 1-1/4 yards (includes binding)

Fabric 7: Medium size print — 7/8 yard

Fabric 8: Large print 1-1/2 yards or Border print 2-1/2 yards

QUILTING TERMS

*HST means half-square triangle. That is a square cut once diagonally to create two triangles.

*QST means quarter-square triangle. A square cut twice diagonally to create four triangles.

*WOF means Width-of-Fabric. Strips that are cut the full width of the fabric (40"-42").

*LOF means Length-of-Fabric. These are strips that are cut parallel to the selvage edge such as border prints. *All seams are sewn with a $\frac{1}{4}$ " seam. Be sure to measure each section before moving on and make adjustments on the way.

*Test your $\frac{1}{4}$ " seam allowance before sewing. Cut three 1-1/2" strips and sew them together. The center strip should equal exactly 1 ". If it is smaller, the seam is too big, if it is larger, the seam is too small.

PART 2

CUTTING INSTRUCTIONS

Fabric 1

Cut: (5) 2-3/8" x WOF strips. Sub-cut into (72) 2-3/8" squares. Cut each square once diagonally into (144) HST.

Fabric 2

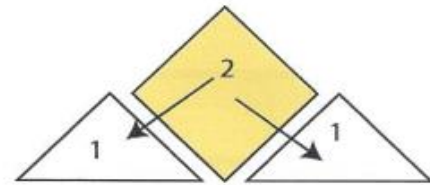
Cut: (4) 2" x WOF strips. Sub-cut into (72) 2" squares.

Fabric 3

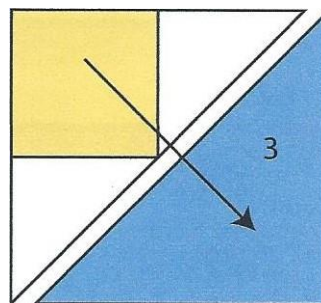
Cut: (4) 3-7/8" x WOF strips. Sub-cut into (36) 3-7/8" squares. Cut each square once diagonally into (72) HST.

SEWING INSTRUCTIONS (Press in the direction of the arrows.)

1. Sew (2) 2-3/8" Fabric 1 HST to two sides of the 2" Fabric 2 square.



2. Sew the 3-7/8" Fabric 3 HST to the unit from step 1. Unit should equal 3-1/2" square. Make (72) units.
